THE CENTER HAS DEVELOPED A STRATEGIC MASTER PLAN FOR THE FUTURE THAT INCLUDES THE FOLLOWING OBJECTIVES: (1) TO CONTINUE TO PROVIDE SAFE AFFORDABLE HOUSING ON SITE, (2) PROVIDE UPGRADED AMENITIES, (3) EXPAND AFFORDABLE HOUSING TO THE ELDERLY, (4) ADD OTHER AFFORDABLE HOUSING AND MIXED USES CONSISTENT WITH NEIGHBORHOOD PLAN, AND (5) BE GOOD STEWARDS OF THE CENTER'S LAND. THE CENTER HAS DEVELOPED A STRATEGIC MASTER PLAN FOR THE FUTURE THAT INCLUDES THE FOLLOWING OBJECTIVES: (1) TO CONTINUE TO PROVIDE SAFE AFFORDABLE HOUSING ON SITE, (2) PROVIDE UPGRADED AMENITIES, (3) EXPAND AFFORDABLE HOUSING TO THE ELDERLY, (4) ADD OTHER AFFORDABLE HOUSING AND MIXED USES CONSISTENT WITH NEIGHBORHOOD PLAN, AND (5) BE GOOD STEWARDS OF THE CENTER'S LAND. THE CENTER IS THE SOLE OWNER OF THE MANAGING MEMBER OF AGC RBJ LLC, A TEXAS LIMITED LIABILITY COMPANY FUNDED BY TAX CREDIT INVESTORS THAT WILL SOON COMPLETE A NEW 279 UNIT HOUSING FACILITY FOR LOW INCOME SENIORS IMMEDIATELY ADJACENT TO THE TOWER OWNED BY THE CENTER. ONCE THE NEW FACILITY IS COMPLETE, THE RESIDENTS WILL MOVE INTO THE NEW FACILITY AND THE TOWER WILL BE RENOVATED FOR OCCUPANCY BY LOW INCOME SENIORS.
